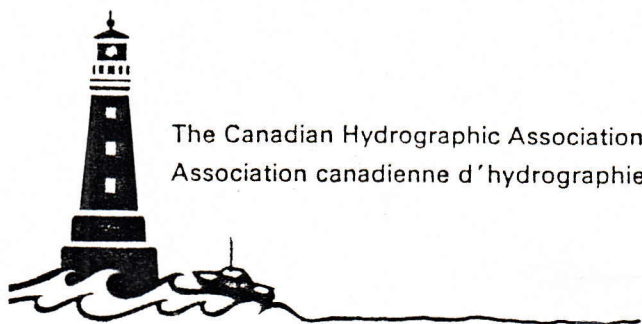

Grandfathering and the AOLS  
from the talk given by S.J. Statham

The Association of Ontario Land Surveyors (AOLS) is a self-governing body established under the authority of the **Surveyors Act** [licensing of surveyors]. This Act has recently been revised by a new **Act to Revise the Surveyors Act**. This expands the profession to include members of other surveying disciplines and provides a professional home for all branches of surveying in Ontario.

To carry out legal (cadastral) surveys in Ontario one works towards being licensed as an OLS and upon qualification can become a member of the AOLS and use the letters OLS. Under the new Act, surveyors in the disciplines of hydrography, photogrammetry and geodesy (and probably also land information systems) can apply for a Certificate of Registration and also become full members of AOLS but without the licence to perform legal surveys.

The education required is a degree in surveying from the University of Toronto or the equivalent, and there is also a two-year articling requirement.

The new Act received First Reading in July 1986 and Royal Assent in February 1987. Regulations and By-laws have been drafted and the last Regulation - dealing with the Grandfathering provision - is now being finalised. At this time the Regulations are still proposed and they may change.

The Grandfathering Regulation allows work at the professional level to be accepted in lieu of an article period. Applicants would attend a mandatory one or two day course on ethics and the AOLS, and may be required to take a written exam and an oral examination. The work experience is proposed to be 3 years with a university degree, 5 years with a college diploma, or 10 years for someone with no degree or diploma. These requirements are flexible and each case will be considered on its own merits.

In the AOLS there are specialist committees on hydrography, photogrammetry and geodesy. People entering from these fields would take an active part in the work of their committees. Annual dues would be half the fee scale [\$750] for licensed members.
