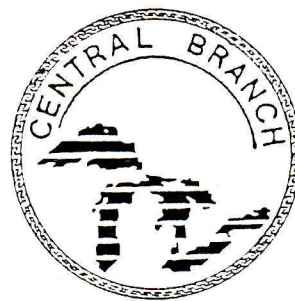

2) MINUTES: The minutes of the last newsletter had been circulated in the last newsletter. It was moved that they be accepted.

3) CORRESPONDENCE: Sam reviewed recent mail: as well as the usual membership mail we have received a newsy letter from Steve Nelson [in Ottawa but retains Central Branch membership]; "Personality" notes from Jordan Smith and Lt.Cdr. A.R. Al shehri; and a newsletter from Newfoundland Branch. We also expressed our sympathies to Sean and his family in the recent loss of his brother-in-law.

4) TREASURER'S REPORT: Terese presented the treasurer's report for the period 14 March to 30 September 1990 and moved that it be accepted.

MOVED: T. Herron and B. Power CARRIED

5) LIGHTHOUSE: Sam reported that Lighthouse was in the process of being prepared. Bruce has five articles in hand and Lighthouse will be out on schedule. The CHA and CHS news will be separate columns in the next issue.

6) NOMINATIONS: Terese closed the nominations during the meeting and reported that based on our membership formula we will again have seven Branch executive members in addition to the V-P and Sec/Treas. Sean Hinds and Terese Herron will be V-P and Sec/Treas. for 1991. There were 13 nominees for the 1991 executive, unfortunately 6 people had to decline due to other commitments. We will miss Boyd Thorson who will be moving to Ottawa in the near future and we wish him well in his new position. Larry Robbins also declined but will remain as our foreign correspondent. It was moved that the nominations be closed and accepted.

MOVED: Ab Rogers and J. Delle Fave CARRIED

We thus have a full slate of officers for our 1991 Central Branch executive. Along with the Vice-President and Secretary-Treasurer, the executive members for 1991 are: Jim Berry; John Dixon; Al Koudys; Ken McMillan; Brian Power; Keith Weaver; Sam Weller. The officers will be installed at the AGM on 30 November.

7) AGM DINNER: Jim Berry reported that the Annual General Meeting of Central Branch will be held on 30 November at the Mimico Cruising Club in their new clubhouse facilities. The seating capacity of the hall -

looking out over the yacht club basin - is 50 people so that is the number of tickets available. We will have a guest speaker. The tickets will be \$20.00 for members and \$30.00 for non-members. There will be a cash bar. Spouses are welcome but members have first call on the 50 tickets. Jim also reported that ROMOR Equipment and McQuest Marine have kindly offered to supply bar nibbles and wine, respectively, for the event. This will be a fitting locale for a fine evening.

8) MEMBERSHIP: Sam reported that there are 39 In-House members; 33 Out-House members; and 32 International members as of 9 Oct. This gives a total of 72 Central Branch members.

10) NEW BUSINESS: The Canadian Hydrographic Conference being held at Rimouski April 16 to 18, 1991 is not being co-sponsored by CHA. Ken expressed serious concern at the increase in the cost of space for exhibitors: \$1,500. compared with \$600 at the Vancouver conference. He is aware of six regular sponsors who have declined to participate this time because of this high cost. Jim said this would be the first Canadian Hydrographic Conference he'd missed, primarily because of CHA not being involved.

11) The meeting adjourned at 20:35 pm.

From our International Correspondent

There are apparently a number of signs that one is getting old. In addition to the obvious signs of advancing decrepitude, policemen (and charge surveyors/party leaders) seem to get younger and time appears to accelerate. It is hard to believe that OI'90 has come ... and gone ... already. I certainly enjoyed the exhibition and the conference papers that I attended and by all accounts it was one of the best ever.

Canadian companies and services were ably represented though I couldn't find too many CHA members amongst the reps there. Fertile recruiting ground perhaps?

CHA members, though, do seem to pop up in the most unexpected places, and it was good to meet up with **ROBERT MORGAN** in (of all places) the grand kitchen of the Royal Pavillion, Brighton's landmark from the Regency Period during a reception. I am pleased to report that Bob behaved himself with decorum, though he appeared to be disappointed at not being permitted to sit at the banqueting table in the main dining room! No discrimination there though, for no one was, and indeed the staff were vigilant in ensuring that no glasses were placed on the splendid antique furniture.

There were no less than five other members at the same function - **JACK WALLACE, JOHN POINTON, KEITH MILLEN** and myself plus **ANDREW REDWOOD** of Racal Marine Systems who, along with **PAUL DAY** of the same company, had recently joined. A respectable percentage of the total attendance!

The U.S. Hydrographic Conference '90 was next on the agenda and the program was good and varied and the US hospitality lived up to expectations. No less than 17 national hydrographic services were represented - including Canada who enjoyed a high profile through the papers presented and the presence there of the SWATH vessel "Frederick G. Creed" which was under charter to NOAA/CHS for evaluation. I had a cruise in the "Creed" and was very impressed by her though, needless to say, the day proved to be excellent for a cruise but not for a demonstration of a vessel whose sea-keeping abilities are, apparently, excellent. One of the few times when I have hoped for rough weather. The cook's unsolicited testimonial story of "the onion which would not roll about the galley even in bad weather" went some way towards demonstrating the vessel's bona fides and I'm sure we'll see more of these vessels being used for hydrographic surveying in the future.

The program for Hydro '90 - the Seventh Biennial International Symposium of the Hydrographic Society (Southampton, UK in December 1990) - has been published and an interesting set of papers is promised there too. The CHA is a co-sponsor and there are a couple of papers from Canadians so one hopes for a good CHA attendance at the Conference.

I have had a couple of letters from international members recently but it would be good to hear from YOU:

IAN BARTHOLEMEW, Lt. Cdr. RN, presently Chief Hydrographer in Fiji, wrote with news from the South Pacific and says it is hoped he will be able to hand over to a Fiji national soon, staying for a few months as advisor. Ian is latest (and perhaps last) of a series of RN officers posted to Fiji since 1979. Nearly 50% of his survey staff of 17 have trained overseas (Pakistan, Canada, NZ) during the last year and two of his three cartographers have likewise been gaining experience overseas. The survey vessel TOVUTO (called BABELE before the Service was civilianised) has undergone extensive maintenance recently and a 5.3 metre catamaran has been built locally to replace the aging wooden motor boat previously used. Thanks for the news, Ian. Hope you're enjoying the 4 o'clock rain showers of this time of year!

GEORGE GOLDSTEEN too wrote a while back: studying for Master's degree in Surveying Science in Sydney, Australia. Hope studies go well, George. Must be interesting (?) on the other side of the lectern for a while!

Finally, sports news. Cricket is the English summer game and each year the Royal Navy's Hydrographic Branch play Racal for a trophy made of three Trisponder antennae in the shape of stumps (the things cricketers throw the ball at). Despite not knowing the rules but ostensibly because I enjoy a foot in both camps (working with Racal but serving the Queen) and thus deemed impartial, I was "invited" to umpire. 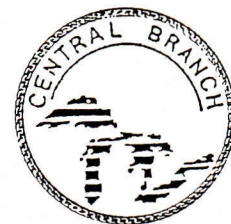
Welcome aboard!
