Notes from the Branch Vice-President

I'd like to take this opportunity to thank those of you who took the time to exercise your democratic rights in the 2000 Executive election. We have a lot of new blood this time around, which is a good thing for the Branch. I am grateful for the opportunity to serve one of the stronger Branches in CHA. I'm also pleased to have the chance to stand up on my box of sounding rolls to offer up some food for thought to this fine newsletter.

As I write my first message to you as VP, I am aware of a stack of books across the table that require my attention. Some of our members across Canada are in the midst of what has become a yearly ritual of hitting the books in preparation for challenging the Canada Lands Surveyor (CLS) examinations. Our colleagues who preceded us were fortunate enough to obtain their commission either through a "grandfathering" clause or by guidelines that afforded them many exemptions from writing the whack of exams confronting CLS candidates today.

Why do it? You might well ask. A CLS commission is what qualifies a surveyor to delineate offshore property rights. Our hydrographers survey, chart and consequentially delineate our Offshore Canada Lands, lands that fall under the jurisdiction of the government of Canada. A CLS commission is a prerequisite for those seeking Engineering Survey (EN-SUR) positions within CHS. A university degree in a geomatics-related area of study will also suffice as will an Ontario Land Surveyor's ticket but I believe this disparity has created some problems, not only for the credibility of the CLS commission itself but also in the notion of the identity of the hydrographic profession. Some time ago the CHS, under the direction of Steve MacPhee, chose not to maintain IHO/FIG Category-A accreditation for their hydrographic training courses. The Dominion Hydrographer believed that by fulfilling the requirements to obtain a CLS commission, the hydrographer would hold an equivalent qualification.

In closing, I leave you with a couple of thoughts to ponder: If an Ontario Land Surveyor (OLS) wanted to practice in Saskatchewan, he or she would have to get an SLS. That said, should not the same standards apply with respect to the survey of Offshore Canada Lands?

Once Canada ratifies UNCLOS'82 (United Nations Convention on Law of the Sea, 1982), should the hydrographer-in-charge of an offshore survey not have to be a qualified CLS?

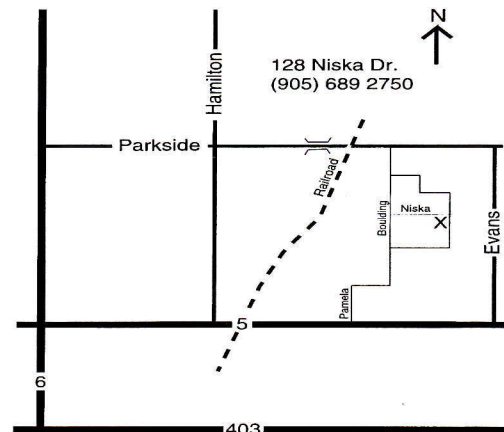

Minutes of General Meeting of CENTRAL BRANCH held on 19 January 2000

1) Heimo Duller and Leigh Morrison hosted the meeting. Andrew welcomed everyone, thanked Heimo and Leigh, and called the meeting to order at 19:30.

In his opening comments, Andrew stated that the CHA should try to maintain our longstanding good relationship with the CHS, as it has proven mutually beneficial in the past. He said that it is important that we define to both the CHS and to CHA membership the benefits that the CHA has to offer. Also, some members have expressed reluctance to renew because of our problems getting Lighthouse out the door, therefore, we should offer our assistance to the Lighthouse Committee to get the outstanding issues published as soon as possible. Andrew thanked Sam for his efforts in the newsletter and urged the Executive to help Sam in this endeavour wherever possible. He also said that he would like to see that future seminar topics are more closely related to hydrography, with these seminar topics possibly developing into papers suitable for publishing in Lighthouse.

2) Minutes of the 9 December AGM were circulated in the newsletter and available at the meeting.

3) Treasurer's report: (A. Leyzack for J. Weller) Sam had not quite finished, but a partial statement was presented to the meeting. The completed statement and budget will be published in the newsletter. Earl asked how the statement compared against last year's. Andrew answered that it was about the same, but we need to run some sort of revenue generating event this year, possibly a GPS raffle.

4) Budget: The 2000 budget was circulated. John Medendorp asked if any expenditures were different than last year. Andrew said there were no significant differences, and stressed that we have to keep a balanced budget and show no profit. Due to lack of interest, the Professional Development funding was dropped. The *Wade Essay Award* was changed to the *Gerry Wade Committee* (discussed later in the minutes). The H<sub>2</sub>O budget was held the same value as last year. There was a \$75 expenditure in 1999 for the purchase of the book *Mapping of Northern Canada, 1947-1994* for the Branch. Mike Marsden suggested having a BBQ as a fundraiser, which is a consideration.

5) Correspondence: Andrew said that there was a reply from a letter to the Minister Canadian Heritage, which listed some recommendations for funding our Admiralty Launch *Surveyor*. George Goldsteen wishes all well for 2000, and expressed concern over the status of Lighthouse. There was a Christmas greeting from Larry and Jane Robbins.

6) Committee Reports: The 2000 committees have been set, and they will appear in the next newsletter. There was a discussion of the change from the *Wade Essay Award* to the *Gerry Wade Committee*. Due to lack of interest in the *Wade Essay Award*, Andrew proposed that we replace this committee with a "*Gerry Wade Committee*". It would be geared towards education in the memory of Gerry Wade. The first step would be to get a bookcase and fill it with such items as the Hydro 99 videos and notes and any other educational material the Branch acquires, with one or two members administering the lending of this material. Free access to this library would be a benefit of CHA membership; there would be a nominal fee levied for non-member users. It was clarified that the bookcase would bear the name "*Gerry Wade*" in some way. Earl suggested trying to get a small office in CCIW, either in the hydrography area or in the library, where this resource material could be stored, read, or viewed.

8) Other Business: Ab asked about the status of George Macdonald's book. Brian answered that the project was stopped by CHS due to controversy in the book's content.

Earl asked for a summary of the recent National Branch AGM (dealing with 1998 affairs). Brian said that Pacific, Prairie Schooner, Central, and Ottawa Branches were represented, and that Branch yearly activities and financial statements were presented. There was a discussion on the issue of transferring funds from the accounts of long-standing dormant Branches to National Branch coffers. Lighthouse was also discussed, and though nothing was resolved, a Directors' meeting to address the issue is in the works. Andrew expressed a need to locate the CHA letters of incorporation. The student awards program was another issue: excess Conference funds from Pacific Branch were given to the British Columbia Institute of Technology and to the University of Victoria to fund annual bursaries, which was a conflict with the existing *CHA Student Awards* program. There was a debate on whether the Board of Directors should administer such funds in the future.
