Earl Brown, acting chair in our V-P's absence, called the meeting to order at 19:15, welcomed everyone; thanked Keith for his hospitality. Central Branch has been active since our last meeting; hosted the Multibeam course in Burlington, co-hosted the CHC 2002 conference in Toronto; held our Central Branch Barbecue; and issued our summer NewsLetter.

3) Treasurer's Report: (J. Weller) for 31 December 2001 to 10 October 2002. The National President and Board of Directors are working on a formula to allow Branches to share revenues from Branch-sponsored events; there was discussion of past experiences of this nature. There are other advertising revenues in Lighthouse's own account.

4) Correspondence: Letters: to Simrad with thanks for support of the MultiBeam course; with prospective members; and news release from Knudsen Engineering for the next Edition of our journal Lighthouse.

5) Committee Reports:

Admiralty Launch Surveyor (B. Power). We took part in no black powder events this year due to insurance limitations. *Surveyor* was active at CHC2002. Admiral Ritchie was also very active there on our behalf. A colour photo of us made the front cover of Hydro International. Since then, static displays at Sarnia in July for the 40th anniversary celebrations for Canadian Coast Guard, and at Grimsby in August for their Festival of The Forty drew a lot of attention and some former CHS staff. The launch was asked to be in a movie being shot on Toronto Island and at Penetanguishene in September. The launch was on display in Port Dover, part of a tall ship display after Canal Days at Port Colbourne. Some maintenance is needed before storing her for the winter. The launch is back in CHA's care: the Memorandum of Understanding with Marine Heritage Association has been terminated. Brian was CHA rep (for *Surveyor*) at discussions of a proposed museum around HMCS *Haida* in Hamilton Harbour. Another option is the active re-enactment program around Kingston. Earl said we could benefit from a PR person to raise our profile in our own community and with local councilors and politicians.

Social events (F. Oliff): Annual General Meeting has moved to Thursday 12 December. Speaker is Paul Carol of Goderich, speaking on the discovery of the 1913 wreck of *SS Wexford* not far from Goderich Harbour.

Educational committee: (F. Oliff): The conference registration desk was very successful and ran smoothly. There was some difficulty at first getting volunteers; some CHA folk from our other Branches also helped and were much appreciated.

Gerry Wade Memorial Library: (E. Brown for T. Janzen) Our Gerry Wade Memorial Library now has a plaque and a digital catalogue of the collection.

MultiBeam course (P. Davies): The course had 47 registrants, which was 10 more than planned, and thus generated more income. There was some revenue after all expenses were paid, plus a Sponsor cheque for \$250.00. This has been transferred to the Branch's bank account. All survey disciplines were represented, from 11 countries; three survey launches were available for demonstrations; grand finale was a cruise on Toronto harbour on schooner *Challenge*. There have since been calls asking about a subsequent course. Is this Branch interested in hosting the course again?

Lighthouse Committee: (E. Brown) Articles and reports are in and next issue is under way but Paola, who does layout and a lot of other work, is in the Arctic. After the great expense of colour in recent editions, this will be mostly black & white, as it was until recently. Earl contacted many people at the conference but these have yet to bear fruit, though there are new members & subscribers, and two Corporate Sponsors. We hope others follow the fine example of CCG & CHS in this regard.

Membership Committee: (B. Power) Several expressions of interest since the conference, and a few new paid-up members. Total [to Oct 10] is 91: 34 In-House, 31 Out-House; 14 International; 4 Life; 7 Sustaining; 1 Honorary. Two former members have not renewed.

Elections Committee: (B. Power) A motion was made to open Nominations for Central Branch executive for the year 2003, to close at the next meeting.
